Panel 1: The role of e-Governance and artificial intelligence in promoting inclusive approaches for access to information

If the digital divide is fuelled by social and economic inequalities, it can also widen the gap by creating further barriers to good public governance implementation, such as the right to access to information. However, the digital divide can also be narrowed by implementing e-Governance initiatives that incorporate the development of applications and online content to enable and encourage self-sufficiency, participation, and collaboration. Following the 13th edition of the

International Conference of Information Commissioners on access to information, participation, and inclusion in the digital age, this panel will define the role of e-Governance and artificial intelligence, while exploring how to turn them into an ally for promoting inclusive approaches for access to information.

Panel 2: Transparency by Design: How to ensure participation and accountability in the digital era

In cooperation with Open Government Partnership & Access Info Europe

As public bodies make increasing use of digital solutions, with Artificial Intelligence being used to support e-governance systems and to aid decision making, it is essential that these processes are subject to the same transparency and accountability as traditional administrative processes. The digitalisation of government services is also still partial, with a paucity of data in some sectors of government and too few decisions are benefiting from data-driven evidence. Drawing on the conclusions of the 2021 Open Government Partnership Global Summit, which underlined the importance of civic space and public participation and promoting inclusive digital innovation, this panel aims to get a clearer picture of the current state of digitally driven governance and will identify specific challenges and recommendations for action by UN bodies, governments, and civil society.

- Which mechanisms should be put in place to ensure transparency and accountability of the use of Artificial Intelligence in e-governance and decision making?
- How can the public participate in the construction of digitalised decision-making processes that make use of Artificial Intelligence and algorithms to ensure equality and inclusivity in these new systems?
- How can privacy and persona data be protected in the age of digital government and transparent, open data?
- How can digitalisation of governance be advanced in a way that increases the effectiveness of decision making in the public interest while still delivering transparency and accountability?
- What standards and accessibility requirements should be designed in to ensure the right of access to digital records?

Panel 4: Measuring Progress on Access to Information Laws and Implementation (UNESCO SDG 16.10.2 Report – 2022)

In Cooperation with IPDC

UNESCO, via its International Programme for the Development of Communication (IPDC), has been mandated by its Member States to monitor and report progress on SDG Indicator 16.10.2 on Access to Information. Every year UNESCO conducts a Survey on Public Access to Information to track progress on the adoption and implementation of “constitutional, statutory and/or policy guarantees for public access to information”. The 2022 survey gathered responses from 123 countries and this panel will explore trends gathered from the 2022 survey and explore synergies with other initiatives to gather data related to SDG 16.

- What lessons can be drawn from the trends on Access to Information implementation around the world?
- Does the survey adequately reflect which mechanisms are effective to safeguard the right to access to information for marginalized groups?

Panel 5: Presentation of the updated Policy Guidelines for the Development and Promotion of Governmental Public Domain Information;

In cooperation with IFAP

The updated version of UNESCO’s ‘Policy Guidelines for the Development and Promotion of Governmental Public Domain Information’ will be presented for endorsement. The purpose of the Policy Guidelines is to build impetus in the development, promotion, production, dissemination, preservation, and use of public information, with particular attention to information in digital form. It recommends that information produced by public entities in all branches and at all levels should be publicly accessible, unless clearly defined as an exemption. The speakers will review the guidelines during the session, and the audience will be invited to provide its remarks.

Panel 6: Implementation of the UNESCO Open Data guidelines in support of transparency, innovation, and e-Governance

Panel 7: Presentation of the online training toll on access to information

Implementing laws giving individuals a right to access information held by public authorities, or right to information laws, is complex whether viewed from the perspective of those supplying information – i.e. public officials – or those demanding it – i.e. civil society, journalists, academics and ordinary citizens.

To help both officials and requesters better understand how to implement right to information laws, UNESCO and the Centre for Law and Democracy (CLD) have developed a self-paced online course, titled *Access to Information Laws and Policies and their Implementation*. This session will introduce the course, outline the benefits of taking it and give a taste of what is included in it.

Panel 8: The future of access to information: Ensuring complementarity between the right to information and personal data protection

(Panel is transmitted by video link from OECD Paris HQ, available by video in Samarkand Hall)

The Organisation for Economic Co-operation and Development (OECD) has played a significant role in promoting the importance of transparency – and access to information in particular – alongside the benefits of open government more broadly. At the same time, personal data protection and privacy are fundamental values which must continue to be protected by governments as they embrace the digital transformation and collect and store ever-vaster amounts of data. In this regard, emerging challenges for public administrations in taking a balanced approach to access to information and personal data protection have become evident in recent years and ensuring that neither are unduly restricted.

It is within this context that, increasingly, the institutional oversight bodies responsible for these policy areas are identifying synergies in safeguarding both interconnected rights. Although both are treated as separate legal frameworks in most countries and require different technical capacities and training, recognised complementarities are pushing governments to consider centralising these areas through a single institution. While not necessary, this dual responsibility can allow institutions to recognise and exploit connections between both policy areas and ensure that personal data and privacy are defended while still enabling full access to

public information. This panel will focus on the linkages and tensions between access to information and personal data protection and discuss how public bodies can better understand them and find ways to enhance – rather than limit – both rights.
